## GROUPS FOR OFFICIAL TRAINING / ACCREDITATION:

The final training mode and composition of the groups will be published according to the entries after 31st August 2018 on the EMF and organizers website and at the official information board at the location. Accreditation of all participants (players, coaches and officials) has to be filed immediately after their arrival, latest on first official training day.

pairings will be regrouped according to the results after first day of competition

### SATURDAY, 6th October - THIRD DAY OF COMPETITION

Qualification: the first 6 women's and men's teams, also teams equal in score to the 6th, qualified  
08:00 3 rounds for each qualified team  
pairings will be regrouped according to the results after second day of competition  
Sudden death immediately after the end of last round  
After competition: medal ceremony on the course  
20:00 victory and closing ceremony

## Penalties System

### Penalties for players

The standard system described in WMF worldwide international sport rules chapter 2.3.18 is used in the team. Referees have the possibility to skip the pre-warning level in case of severe or tactical violations. All penalties are also announced via loudspeakers.

### Penalties for coaches

For coaches, the standard penalty system described in WMF worldwide international sport rules chapter 2.3.19 is used throughout the entire tournament. Referees have the possibility to skip the pre-warning level in case of severe or tactical violations.
